Re : 6 termination Notices each dt. 02-04-2018 issued by the Company to Kirloskar Brothers Ltd.

We refer to the following trademark User agreements executed by you:

- 1) 01-08-1977 and subsequent supplemental agreements
- 2) 07-09-1983 and subsequent supplemental agreements
- 3) 01-08-2001 and subsequent supplemental agreements
- 4) 16-02-2005 and subsequent supplemental agreements
- 5) 31-01-2008 and subsequent supplemental agreements
- 6) 21-04-2017.

(collectively the "licences")

As you are aware that pursuant to six termination notices each dated April 2, 2018 (collectively the "**Termination Letters**"), we had terminated the Licences on terms and conditions set out in the Termination Letters.

The said matter was taken up in the meeting of our Board of Directors held on 03-03-2020.

The Board of Directors considered the matter and decided to withdraw the Termination Letters dt. 02-04-2018 issued to Kirloskar Brothers Ltd. with effect from 3rd March, 2020 in view of your willingness to settle all matters raised by you pertaining to the Kirloskar Marks owned by us.

Accordingly, on and from 3rd March, 2020 the licences will become effective once again and you shall be permitted to use the trademarks licenced under the Trademark Agreements as a licensee on terms and conditions set out under the respective Trademark Agreements.

The said withdrawal of Termination Letters would be informed to the Hon'ble Court on 05-03-2020 in the matter being Civil Suit No. 40 of 2018 filed by you before the Hon'ble Commercial Court, Pune at Pune.
