Pursuant to the recommendation of Nomination and Remuneration Committee, the Board of Directors of the Company at its meeting held on November 05, 2020 has re-appointed Mr. Sanjay Kirloskar (DIN 00007885) age 63 years as the Managing Director of the Company with effect from November 19, 2020 for a period of 5 years i.e. upto November 18, 2025 subject to the approval of shareholders. At present, Mr. Sanjay Kirloskar is Chairman and Managing Director of the Company.

Kirloskar Brothers Limited was incorporated in 1920 and is one of India's oldest manufacturing companies.
