Dear Sir,

- I, Shyamprasad D Limaye, a Company Secretary in practice, have been appointed by the Board of Directors of Kirloskar Brothers Limited ("the Company") as a scrutiniser for the purpose of scrutinising the postal ballot forms and e-voting and ascertaining the requisite majority on voting carried out as per the provisions of Section 110 of the Companies Act, 2013, read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended, on the resolutions contained in the postal ballot notice dated 26th November, 2020 ("the resolutions").
- 2. The notice dated 26th November, 2020, seeking approval of members of the Company along with statement setting out material facts under Section 102(1) of the Companies Act, 2013 was sent to the members in respect of the resolution to be passed, through postal ballot. In view of various MCA circulars, voting on Postal Ballot was to be exercised only through e-voting, hence the Company had provided remote e-voting facility to the members to vote on the resolution through the electronic voting platform provided by NSDL
- 3. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through postal ballot/remote e-voting on the resolutions for approval of the members of the Company. My responsibility as a Scrutinizer for remote e-voting is restricted to make a Scrutinizer's report of the votes cast in "favour" or "against" on the resolution and "invalid" and "abstained" votes, based on votes cast electronically and the reports generated from the e-voting platform provided by NSDL.
- 4. Further to the above, I submit my report as under:-

- a. dispatch of e-voting notice to its members whose names appeared in the register of members/list of beneficial holders as on Friday, 27th November, 2020 (End of Day) through email at their registered email ID.
- The remote e-voting period remained open from Sunday, 29th November, 2020 at 9.00 a.m. to Monday, 28th December, 2020 at 5.00 p.m.
- c. The members whose names appeared in the register of members as on the "cut-off' date i.e. Friday, 27th November, 2020 (End of Day) were entitled to vote on the resolutions as set out in the E-voting Notice of the Company.
- d. The remote e-voting facility was blocked on Monday, 28th December, 2020 immediately after the completion of voting hours in the presence of 2 witnesses, Mr. Neelkanth G. Limaye and Mrs. Manasi Sathe who are not in the employment of the Company.
- e. There were no postal ballot forms in view of the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for holding general meetings/ conducting postal ballot process through e-voting, vide General Circular No. 14/ 2020 dated April 8, 2020, General Circular No. 17/ 2020 dated April 13, 2020 and General Circular No. 22/2020 dated June 15, 2020 and General Circular No. 33/2020 dated September 28, 2020, in relation to "Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013 and the rules made thereunder on account of the threat posed by COVID 19" issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars")
- Considering votes through remote e-voting the result of the voting is given below. The details containing, inter alia, votes cast in "favor "or "against" on the resolution that was put to vote, and whose votes became invalid and number of votes abstained from voting, were generated from the e-voting website of NSDL www.evoting.nsdl.com. and my report is based on such reports generated.
